Description of Defect :

Description of the Defect : The natural leather seating surface of the front passenger seat can shrink. This condition can impose modest pressure on the occupant classification system (OCS) sensor mat. This can cause the OCS to judge that there is a child in the seat when the seat is vacant. It can also cause the OCS to judge that there is an adult in the seat when the seat is occupied by a child.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : In a frontal impact of sufficient magnitude, the front air bag can deploy even if there is a child in the front passenger seat.

Description of the Cause : Shrinkage of the original passenger seat cushion cover is caused by conditions of variable high humidity and high temperature.

Identification of Any Warning that can Occur : If the OCS judges that there is a child in the front passenger seat when the seat is vacant, the PASS AIR BAG OFF indicator and passenger seat belt reminder light will be illuminated, and the seat belt reminder chime will sound. If the OCS judges that there is an adult in the front passenger seat when the seat is occupied by a child, the PASS AIR BAG OFF indicator will not be illuminated.

Description of Remedy Program : Suzuki Service providers will replace the seat bottom cushion of affected vehicles with a seat bottom cushion that has an insert of synthetic leather on the seating surface. Suzuki Motor of America, Inc.'s plan for reimbursing owners who have paid for repairs to remedy the reported condition in advance of recall notification is attached as a separate document.

How Remedy Component Differs from Recalled Component : The remedy components are seat bottom cushions that have an insert of synthetic leather on the seating surface. The name, description, and part number of the recalled components are provided below.
