Description of the Defect : The VOM74MM mirror monitor (if the serial number starts with A, B, or C) may power ON with an image that is reversed from what is expected.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : With the reversed image on the mirror monitor, the driver may inadvertently turn the wrong direction to avoid an object behind the vehicle, increasing the risk of a crash.

Description of the Cause : The mirror monitor is loading default factory settings, causing the monitor to reverse the image displayed.

12/13/2018 ASA Electronics confirmed the first incident of a reverse image being displayed.

3/18/2019 ASA notified TMC of recall 19E-009 that ASA submitted.

3/22/2019 After discussions with ASA, it was determined that TMC will be handling all recall notifications and reporting and all expenses related to this recall will be charged back to the vendor.

3/25/2019 Engineering has confirmed that there is about a 2 volt drop upon the engine starting in our products.

3/27/2019 TMC's Safety Committee Team agreed that a recall would be issued and a 573 submitted without scope and once we were sure of the scope, we will amend.

Description of Remedy :

Description of Remedy Program : ASA will provide a replacement mirror monitor (REV. E, F, or G) to install that will prevent the image from inverting. (Installation of harness will no longer be used to complete recall repair.) Labor reimbursement will be provided through the normal warranty claim process, which will be sent as a vendor charge back to ASA.

How Remedy Component Differs from Recalled Component : Remedy component will not experience an inverted image.
