Descriptive Information: The sun visor assemblies in some 2019 MY Dodge Charger vehicles may not comply

to the airbag warning label requirements of FMVSS 208 Section 4.5.1(b)(3). The driver sun visor may contain no airbag warning label and the passenger sun visor

may contain airbag warning labels intended for non-US markets.

The suspect period was determined using assembly plant records and tracing headliner assembly part numbers, of which the sun visors are a subassembly. The suspect headliner assemblies, which contained no driver sun visor warning labels and passenger sun visor airbag warning labels intended for non-US markets, were assembled into US market vehicles from May 26, 2018, through February 8, 2019, when vehicles were assembled with the correct headliner assembly part numbers that contained correct US sun visor airbag warning labels on each front outboard visor.

Similar vehicles not included in the recall were built with FMVSS 208 compliant sun

visor airbag warning labels.

- · On February 1, 2019, a 2019 MY Dodge Charger built for the US market, but containing non-US sun visor airbag warning labels, was observed in the Brampton Assembly Plant ("BRAP") Customer Protection Audit.
- · On February 6, 2019, FCA Engineering was notified that non-US sun visor airbag warning labels had been built into some US market vehicles.
- · On February 6, 2019, the content and location of the non-US sun visor airbag warning labels were compared against the requirements as identified in FMVSS 208. Differences between the FMVSS 208 requirements and the non-US labels were identified.
- \cdot On March 21, 2019, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

Description of Remedy:

Description of Remedy Program: FCA US will conduct a Voluntary Safety Recall on all affected vehicles to

replace the driver and passenger sun visors.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the

expense.
