Description of the Noncompliance : Due to missing padded trim kits, certain Supreme service bodies mounted on Ford Transit chassis do not meet FMVSS201U head impact requirements.

FMVSS 1 : 201 - Occupant protection in interior impact

FMVSS 2 : NR

Description of the Safety Risk : Due to missing padding, in the event of a crash there is an increased risk of head injury or death

Description of the Cause : Production build orders improperly omitted the 201U compliant trim kits on some service bodies mounted on Ford Transits.

Identification of Any Warning that can Occur : Missing padded trim at rear of chassis cab.

Chronology :

On or about March 19th 2019, an internal audit determined some production orders were released without having FMVSS 201U compliant padded trim included on the vehicle build order. On March 20th, an exposure analysis consisting of auditing quality inspection photographs of all vehicles mounted on Ford Transit chassis began. On March, 22 2019 the Wabash National Product Safety Council convened and determined that a FMVSS noncompliance existed and decided to conduct a recall on affected vehicles. On March 26th the exposure analysis was completed and determined that 99 vehicles were found to be noncompliant with FMVSS 201U. On March 29th, Supreme submitted its 573-safety recall report.
