**Description of Defect :**

Description of the Defect : Gas springs with an integral, overlapping sleeve lock are used to hold a sliding, lift-up cover in the open position. The lock can be inadvertently rotated into a position that may lead to the lock not engaging when necessary.

FMVSS 1 : NR

Description of the Safety Risk : If the locks do not engage properly, the sliding, lift-up cover may come down without warning and injure personnel working under the cover.

Description of the Cause : The lock can be inadvertently rotated into a position that may lead to the lock not engaging when necessary.

**Chronology :**

On February 11, 2019, KME was notified of a customer concern about sliding, lift-up covers on several of their trucks falling unexpectedly. An internal investigation was initiated and trucks of similar design in production were reviewed to determine the problem. Multiple gas spring suppliers were consulted in the process. It was determined that the locking mechanism could be disabled by inadvertently rotating it, while the lock would still appear as though it was functioning. On March 29, 2019, it was decided that a recall was necessary.

**Description of Remedy :**

Description of Remedy Program : KME or its dealers will replace the gas springs on the sliding, lift-up cover at no cost to the owner with either:

- a) New gas springs with an integral locking mechanism that cannot be inadvertently disabled, or,
- b) New gas springs without the integral locking mechanism and a separate fabricated cover stay arm.

How Remedy Component Differs from Recalled Component : The replacement gas springs do not have the integral overlapping sleeve lock.

Identify How/When Recall Condition was Corrected in Production : The same remedies are being applied to the trucks currently in production.
