04/10/2019: During a routine production line audit, REV RV's Compliance Engineer discovered that the generator exhaust on a MY 2019 Flair model 32 S was installed incorrectly and extended into the departure angle, near the rear of the motor home. REV RV's Operations team reviewed the production application, and upon further investigation, determined that production assemblers were building per print. REV RV Product Development and Engineering reviewed the application and determined that the generator exhaust pipe was routed out the side of the unit, but the departure angle posed an interference with it. The issue was brought to the attention of senior management and a Stop Ship was implemented to quarantine all Flair and Admiral model 32 S motorhomes pending completion of the investigation. It was determined

It was determined through plant inspections; that the scope is limited to the 32 S models for model year 2019 Flair and Admiral motor homes; this was a new model introduced for 2019 model year and did not share a generator exhaust routing configuration with other models.
