In the end of February 2019, DAG launched initial investigations based on a finding in the production plant, which reported a tilted brake pedal plate. These analyses indicated an impaired welding of the brake pedal plate to the brake pedal lever.

In March 2019, in cooperation with the supplier, DAG determined that preliminary parts produced during the calibration of the welding robot had entered the supply chain. Subsequently, the range of potentially affected vehicles was identified via supply documentation and production records.

In April 2019, DAG determined that a potential safety risk cannot be ruled out.

Description of Remedy:

Description of Remedy Program: An authorized Mercedes-Benz dealer will check the welding of the brake

pedal on the affected vehicles and replace the brake pedal, if necessary.
