- · On July 19, 2018, the FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall U74 (NHTSA recall #18V-486) on certain 2015-2017 MY Ram pickup trucks equipped with a power locking tailgate, excluding vehicles with an 8 foot truck bed.
- · From July 2018 to April 2019, FCA US Vehicle Safety and Regulatory Compliance ("VSRC") monitored and analyzed trucks equipped with power locking tailgate not included in NHTSA recall #18V-486 for incidents in the field related to the tailgate inadvertently falling open while driving or stationary.
- · As of April 29, 2019, FCA US identified approximately 60 CAIRs, 7 VOQs, and zero field reports potentially related to this issue.
- · As of April 29, 2019, FCA US identified 127 warranty claims and repair orders potentially related to this issue.
- · As of April 29, 2019, FCA US is not aware of any accidents or injuries potentially related to this issue.
- · On May 2, 2019, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary

safety recall of the affected vehicles.

Description of Remedy:

Description of Remedy Program: FCA US will conduct a Voluntary Safety Recall on all affected vehicles. The remedy for this item will limit the locking actuator travel and not allow the pivot arm from overtraveling and pulling on the locking/unlocking rods.

> FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the

expense.
