Description of the Defect: In some circumstances, the fuel pressure inside the tank may, in extreme cases,

cause fuel to "spray" when opening the fuel cap.

The situation described above is more likely in hot weather conditions.

Description of the Safety Risk: Fuel spray may cause injury, when opening fuel cap.

Description of the Cause: Too much pressure inside the fuel tank, more likely in hot weather conditions.

it is sufficient to wait until the stop of the hiss, before opening the fuel cap

Chronology:

In Q4 2018 and Q1 2019, few customer fuel spray cases were reported to DMH. All of them where reported only when bike is stopped and customer is opening the fuel cap.

DMH spent Q1 2019 to investigate case by case in order to replicate the same condition.

On May 14, 2019 the DMH Safety committee decided to launch a voluntary recall.

No injuries nor fire cases were reported.

Description of Remedy:

Description of Remedy Program: An official Ducati dealer will provide an updated page for customer

owner's manual and will affix a warning label decal to the unit's fuel tank.

Additionally, the venting system of the fuel cap will be updated.

This will be performed free of charge. A Ducati North America Recall Bulletin is scheduled to be published to the Ducati North American Dealer Network using the established communication process. Owner notification letters are expected to be mailed within 60 days of submission of this

report. All of the subject vehicles covered by this recall are under

manufacturer's warranty.

How Remedy Component Differs The updated owner's manual page and fuel tank decal will increase from Recalled Component: customer awareness and provide necessary precautions for customers to

follow when opening the fuel cap.

The venting system will be updated in order to improve the venting flow

capacity from the tank.
