Description of the Defect : As the monitor powers up (takes a few seconds) at a specific time it loads the user defined settings. If the power up sequence is interrupted by a power drop at a precise time the monitor may not be able to load the user settings and will load the default settings which will reverse the image on the monitor. The user defined setting for image is "NORMAL". The factory default setting for image is "MIRROR".

April 2019 – ASA Electronics notified Mickey Body of the issue and that ASA has filed recall (19E-009). ASA would send end user letters if Mickey Body supplied VINs and addresses of end users. ASA sent end user notification letters and is sending product and paying labor repairs.
