The vehicle population was determined through production records from the supplier and traceability of the suspect parts, which were used to identify the suspect vehicle production dates. Similar 2019 MY Jeep Renegade vehicles not included in the recall are not equipped with the Upland trim package or were equipped with the Upland trim package but were built before or after the suspect vehicle production date range

- · From May 08, 2019 through May 15, 2019, FCA Italy Safety Center performed Virtual analysis to confirm customer impact and determined that an incorrect stage of air bag deployment could occur in a frontal collision with a longitudinal delta-V below 16 MPH.
- · On June 4, 2019, FCA Italy determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.
