29-May-2019 Vermeer product safety was notified of a customer concern with a Vac-Tron LP873SDT Heavy trailers lighting and reflectors lacking NHSTA requirements. 31-May-2019 a meeting was had with Vac-Tron and Vermeer to discuss customer concerns and it was determined that more research was needed on the Model in understanding the history of the parts list and different year builds. 6-June-2019 confirmed that the Trailer did not meet all NHSTA requirements for lighting and reflective devices. 7-June-2019 Registered Vac-Tron in NHSTA website as a manufacturer.
