### **Chronology:**

On April 5, 2019, Forest Rivers Office of Corporate Compliance ("OCC") received an incident report from the Georgetown/FR3 manufacturing plants' warranty department indicating they identified four vehicles in which the slideroom began extending or retracting without an operators command. On April 10, 2019, OCC, the manufacturing plant and Lippert Components (LCI) opened an investigation into the concern and began reviewing Forest Rivers warranty claims and customer complaints. On April 22, 2019 Forest River and LCI replaced the control module of the slideroom under warranty of the original four vehicles which claimed to have the concern, the slideroom did not activate again without user input. The control module was returned to the partner supplier for testing to identify any failure. On April 24, 2019, LCI's engineering team began reviewing the failed slide controllers to try and identify a failure mode. Forest River stayed in touch with the partner supplier throughout this process. On May 8, 2019, Forest River became aware of an additional nine vehicles with the same like potential failure of the slide controller without operator input. Forest River inquired to LCI as to its findings, which remained inconclusive but still trying to identify if there was a failure. On May 13, 2019 and May 15, 2019 OCC reached out to LCI for updates concerning the slide controller and any findings. At that time the concern was still inconclusive. On May 28, 2019 OCC began working with LCI to review their internal data for warranty claims and customer complaints. On June 12, 2019 OCC received a date range of slide controllers sold to the manufacturing plant. The date range was derived from data suggesting a trend in warranty claims on the slideroom controller from LCI. On June 19, 2019 OCC was able to identify the vehicle(s) that potentially are part of the concern and asked the manufacturing plant to confirm this data. On June 21, 2019 Forest Rivers CRC Team voted to recall
