Descriptive Information: Based on production information, the potentially affected population for the global

market was determined to be VS20 Metris (Platform 447) produced between July 11, 2018 and August 31, 2018. The affected steering gears contain an internal sensor not built to specification. The population was defined by vehicles with (1) steering gears

containing the sensor built by this supplier, (2) confirmed to be outside of

specification, and (3) that were not contained and remedied before leaving Daimler's

direct control.

Daimler has learned that two vehicles within the population range left the U.S. vehicle

preparation center before the remedy had been conducted.

Description of the Defect: Daimler AG has determined that on certain Mercedes-Benz Metris vehicles

(Platform 447), an internal sensor within the electric power steering unit might not have been manufactured according to specifications, potentially resulting in an inability to detect the operating position of the electronic motor within

the power steering unit and deactivating the power steering support.

Chronology:

Daimler AG originally became aware of this issue through its supplier in August, 2018. After investigating the issue, DAG decided that a safety consequence could not be ruled out and decided to conduct a safety campaign to replace the steering units of 102 affected vehicles in the field. DAG was able to contain affected vehicles at the U.S. vehicle preparation center and therefore determined that there were no affected vehicles beyond its direct control in the United States. Daimler Vans submitted a foreign recall report on November 26, 2018.

Daimler has since learned that two vehicles may have left the U.S. vehicle preparation center without having the steering units replaced. One vehicle remains in dealer inventory and the other has been registered by the dealer.

DAG decided to conduct a safety recall to remedy these vehicles on June 25, 2019. DAG is taking steps to replace the steering units in these two vehicles as soon as possible.

Description of Remedy:

Description of Remedy Program: An authorized Mercedes-Benz Metris dealer will replace the steering unit

of the affected vehicles.

Pursuant to 49 C.F.R. § 577.11(e), Daimler Vans does not plan to provide notice about pre-notice reimbursement to owners since all involved

vehicles remain covered under the new vehicle warranty.

How Remedy Component Differs The remedy is to replace the steering unit with new steering units

from Recalled Component: manufactured according to specifications.

Identify How/When Recall Condition The recall condition is limited to steering gears with internal sensors was Corrected in Production: including sub-components from a specific sub-supplier. The sub-supplier was used for this specific production lot only in order to cope with peak volume in the affected production period and has not supplied components since.
