Description of Noncompliance:

Description of the Affected vehicles may have the Manual Park Release (MPR) cover not installed.

Noncompliance: FMVSS 114 requires the MPR cover to be in place and removable only with a

tool. The vehicles may also be in Factory Mode, which disables warning alerts and chimes, and does not display the PRNDL positions and selected gear under certain conditions to reduce battery drain during the production process. FMVSS 102 requires the gear positions and gear selected to be displayed

whenever the shifter is not in park.

FMVSS 1: 114 - Theft protection

FMVSS 2: 102 - Trans shift lever seq/starter interlock/trans braking effect

Description of the Safety Risk: If the MPR cover is not installed, the MPR lever may be inadvertently

actuated, which could result in unintended vehicle movement if the electronic

park brake is not applied, increasing the risk of injury or crash.

Description of the Cause: A production process issue may have allowed for vehicles to be shipped

without the MPR cover installed and while still in Factory Mode.

Chronology:

On July 17, 2019, Ford's Customer Quality Indicator System (CQIS) and dealer calls identified six vehicles arriving at dealerships with the IP cluster in Factory Mode. Some of these vehicles had an engaged Manual Park Release (MPR) and/or missing the MPR cover. A stop-ship was issued on July 19, 2019 to contain suspect

On July 29, 2019, Ford's Field Review Committee reviewed the concern and approved a compliance recall action for all affected vehicles.

Ford is aware of one report of an accident occurring during transport, on a vehicle that was previously identified as having an issue with the electronic park brake and had not yet been repaired. The incident resulted in vehicle damage only, and no injuries.

Description of Remedy:

Description of Remedy Program: Owners will be notified by mail and instructed to take their vehicle to a

Ford or Lincoln dealer to inspect for the MPR cover and install it if not attached. The dealer will also verify the instrument cluster is out of Factory Mode and clear any codes that may have been may have been set from the MPR being engaged or the vehicle driven in Factory Mode. There

will be no charge for this service.

Ford is excluding reimbursement for costs because the original warranty

program would provide for a free repair for this concern.

Ford will forward a copy of the notification letters to dealers to the agency

when available.
