Description of Noncompliance :

	Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year ("MY") 2020 GLE-Class vehicles (167 platform) the owner's manuals do not include information specific to the adjustment of the head restraints of the third row seats, as required by local regulatory requirements (FMVSS 202a, S4.7.2(d)).
FMVSS 1 :	202 - Head restraints
FMVSS 2 :	NR
Description of the Safety Risk :	The owner's manual is intended to provide information to the occupant about the appropriate adjustment and operation of head restraints. The owner's manuals for the subject population do not include a description specific to the third row seats. Occupants may not understand how to properly adjust the third row head restraints without the required description, increasing the risk of injury.
Description of the Cause :	The missing documentation resulted from advancing the originally planned implementation date of the third row seating.
<i>v</i> 0	The occupant would be aware to adjust the head restraints due to the ergonomic design.

Chronology :

In Spring 2019, during launch of the model year 2020 GLE-class, DAG discovered that the ECE-specific user manual does not include information specific to the use of the head restraints of the third seat row.

Investigations were initiated to check the nine other market specific owner's manuals for compliance with local laws or regulations. It was determined that, although the owner's manuals contained the general description of the adjustment and operation of the head restraints, they did not contain information specific to the head restraints in the third row of seats.

DAG also determined that the advanced introduction of the third row of seats resulted in documentation errors and the oversight. Additionally, further analyses were performed to determine the impact of the missing information of the 3rd row head restraints on occupant safety. This was determined not to be the case since the customer is informed about the correct adjustment and use of the head restraints by the general explanations

of the head restraints in the user manual. Furthermore, the occupant would be made aware of a potential misadjustment by the ergonomic design of the 3rd row head restraints. On August 30, 2019, DAG decided to conduct a noncompliance safety recall.

Description of Remedy :

Description of Remedy Program :	As a precautionary measure, an authorized Mercedes-Benz dealer will provide a supplementary owner's manual booklet with the necessary information. Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since all involved vehicles remain covered under the new vehicle warranty.
How Remedy Component Differs from Recalled Component :	3rd row headrest supplementary booklet (# A167 584 64 06) includes the required information
	In response to the ECE-based discovery, all owner's manuals globally were updated in production on April 15, 2019.
