or missing bolt/nut, the brake pedal mounting area may deform. Deformation of the brake pedal mounting area could reduce braking

performance, increasing the risk of a crash.

Description of the Cause: A defective bolt feeder may have improperly installed a bolt potentially

resulting in a cross-threading of the nut or missing hardware.

Chronology:

August 29, 2019 - During the vehicle assembly process, an associate discovered an insufficiently tightened bolt. Upon closer review, it was observed that certain hardware located on the brake pedal mounting bracket may have been insufficiently tightened or missing. This topic was escalated within Subaru, and the supplier was informed of the condition.

August 30 - September 4, 2019 – The supplier opened an investigation. The condition was traced to a defective bolt feeder which was removed from service on September 4, 2019.

September 5 - 10, 2019 - Subaru traced the potentially affected brake pedal mounting bracket hardware to a vehicle manufacturing period of July 30, 2019 through August 29, 2019.

September 11, 2019 - Subaru decided to conduct a voluntary safety recall.

Description of Remedy:

Description of Remedy Program: For all of the potentially affected vehicles, Subaru dealers will inspect the

brake pedal mounting bracket hardware at no cost. If the potentially affected hardware is determined to be improperly installed, the hardware

or the brake pedal assembly will be replaced at no cost.
