On 10/28/2019 a Vehicle Owner Questionnaire (VOQ) # 11270775 was filed with NHTSA by a consumer. On November 12, 2019, Forest River's Office of Corporate Compliance ("OCC") was contacted by NHTSA to discuss the VOQ with NHTSA Office of Defect Investigations. An investigation was launched the same day with OCC working with the partner supplier to begin testing on the coupler. OCC reviewed all warranty claims and complaints and found there has not been any claims or complaints concerning the subject coupler.

On November 18, 2019, OCC contacted NHTSA's Office of Defect Investigations to advise the Forest River Corporate Committee would meet to discuss and conduct a vote on the coupler.

During an emergency Corporate Committee meeting on November 19, 2019, the Corporate Committee voted to recall the vehicles.
