In September of 2019 the Piaggio After-sales Department began to report about warranties related to retaining rings broken and lost. In several cases the pin slipped off and the footrest was lost. The Piaggio Engineering Department found that the assembly metod of the retaining ring (P/N AP8120573) may cause deformation of the component or incorrect positioning on the final product.

Description of Remedy :

Description of Remedy Program :	Safety Recall Campaign: Customer brings the motorcycle to the dealer, who is requested to check the retaining rings on all four footrests supplied by Piaggio. If one of the four clips is found to be defective Piaggio will replace all four circlips for the customer free of charge.
U	The remedy component P/N AP8152409 (DIN 471) has a different shape compared to the previous retaining ring P/N AP8120573 (DIN 6799) that is easier to install.
