BMW of North America, LLC is conducting a Voluntary Safety Recall (effective February 27, 2019) on certain Model Year 2019 BMW X7 SAV vehicles that have been produced from October 30, 2018 through January 10, 2019. The attachment bolts for the adapter of the 2nd row business lounge seats may not have been fastened correctly.

Approximately 5 vehicles are affected by this delivery stop/recall.

Affected vehicles show the campaign as "Open" when checked either in Warranty Vehicle Inquiry, AIR or ISPA Next and identified with the description: 0052850100 B520119 Recall: 2nd Row Seat Connection (Option 4U5).

All of the other systems including DAR and the RDR system will show the Stop Sale Sign starting tomorrow. Please utilize the Inventory Campaign Details under ROSS which shows all vehicles that have a Stop Sale in yor inventory.
