Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2019 Dutchmen Aspen Trail, 2019 Coleman Travel Trailers. As a result, Keystone RV is conducting a safety recall.

***Reason for  
this recall***

It has been decided that the vehicles in the recall population have a Capital two-burner cooktop that the burner flame may be affected during furnace operation. Under certain conditions during furnace operation, the burner flame can invert leading to an increased risk of personal injury, and/or fire. The vehicles included in the recall are:
