# IMPORTANT SAFETY RECALL

## Transmission Shift Cable Bushing

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain [2013 - 2016 Model Year (PF) Dodge Dart] vehicles equipped with a 6-speed automatic transmission.

#### WHY DOES MY VEHICLE NEED REPAIRS?

The transmission shift cable on your vehicle <sup>[1]</sup> may have been built with a shifter cable bushing on the transmission end of the shifter which can deteriorate and become detached from the transmission. This condition can result in the inability of the driver to actually shift the transmission, even though the driver may move the shifter handle. The true transmission gear position will be displayed on the instrument cluster and on the display next to the shifter. If the driver's door is opened while the transmission is not in "PARK", the vehicle not in "PARK" and door ajar messages will display on the instrument cluster and audible chimes will sound. **If these warnings are not heeded, unintended vehicle movement and vehicle crash can occur.**

#### HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

**The remedy for this condition is not currently available.** We are making every effort to finalize the remedy as quickly as possible, and will service your vehicle free of charge (parts and labor).

FCA US will contact you again, by mail, with a follow-up recall notice when the remedy is available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment <sup>[2]</sup>. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

#### WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit [www.fcarecallreimbursement.com](https://www.fcarecallreimbursement.com) to submit your reimbursement request online <sup>[3]</sup>. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.

## **New Safety Recall Advanced Communication – V34**

FCA US LLC (FCA US) has announced a safety recall on certain 2013 Model Year through 2016 Model Year (PF) Dodge Dart vehicles equipped with a 6-speed automatic transmission.

VINs identified as being involved in this campaign are currently live and searchable.

**Stop sale is in effect for the above-identified vehicles.**

Vehicles impacted by a stop sale are eligible for reimbursement allowance through the Recall Floorplan Reimbursement Policy (RFPRP), which can be requested upon recall claim submission.

**IMPORTANT:** Some of the involved vehicles may be in dealer new vehicle inventory. Federal law requires you to complete this recall service on these vehicles before retail delivery. Violation of this requirement by a dealer could result in a civil penalty of up to \$21,000 per vehicle. Involved vehicles can be determined by using the VIP inquiry process.

### **REASON FOR THIS SAFETY RECALL**

Some of the above vehicles may have been built with a shifter cable bushing on the transmission end of the shifter cable which can deteriorate and become detached from the transmission. This condition can result in the inability of the driver to actually shift the transmission, even though the driver may move the shifter handle. The true transmission gear position will be displayed on the instrument cluster and on the display next to the shifter. If the driver's door is opened while the transmission is not in "PARK", the vehicle not in "PARK" and door ajar messages will display on the instrument cluster and audible chimes will sound. **If these warnings are not heeded, unintended vehicle movement and vehicle crash can occur.**

### **SERVICE ACTION**

FCA US will conduct a voluntary safety recall to replace the transmission shift cable bushing on the transmission end of the shifter cable. The remedy for this condition is not currently available. Dealers will be notified of the launch of this safety recall by way of established communication methods. This recall is estimated to launch in 2nd Quarter of 2019.

We ask that you please take the time to ensure that your personnel are aware of this communication and are prepared to execute a customer friendly process for inquiries regarding involved vehicles.
