Subject: Launch of Safety Recall 3919G - 2019 Mazda3 - Interior Rearview Mirror Glass May Suddenly Detach From Mirror Housing

Mazda Motor Corporation has decided to conduct a Safety Recall Campaign on certain Japan (MC) and Mexico (MMVO) produced 2019 Mazda3 vehicles within the VIN range below, affecting 22,571 U.S. and U.S. Territory vehicles.

Affected Vehicles:

Action Required:

Currently there are 4,330 unsold affected vehicles in dealer inventory or arriving to a dealership. These vehicles must not be delivered to customers until the recall repair has been completed.

Concern Outline:

The interior rearview mirror glass may suddenly detach from the housing of certain vehicles equipped with "manual" dimming mirrors. Note: Vehicles equipped with "automatic" dimming mirrors are not affected by this recall. The mirror glass was not adequately bonded to the mirror housing during the manufacturing process of the interior rearview mirror unit. As a result, the interior rearview mirror glass on some units may not have full adhesion strength. If the interior rearview mirror glass falls off the mirror housing, the driver may have reduced rearward visibility, which may increase the risk of a crash.

Owner Notification:

Mazda will notify approximately 9,485 owners of affected vehicles by first class mail on September 19, 2019. The remainder of affected vehicles have already been repaired or will be repaired before delivery to customers. Owners will be asked to bring their vehicle to the nearest Mazda dealership for repairs. This recall will be present in the Missed Recalls report starting on September 19th.

Parts Information:

To prepare for this launch, Mazda will process a final push order to begin filling on Wednesday, September 18th. The quantity of parts received from this push will be based on a percentage of the unrepaired affected VINs for your dealership. Part Number BCJH-69-220B. In eMDCS, you can reference the purchase order number for these orders as "RECALL 3919G PUSH."

The Scarcity order page on eMDCS will be removed at 5:00 pm PST on Thursday.

Beginning on Friday, September 20th this part can be ordered through the DAG Restricted Parts Ordering link on MXConnect for Recall 3919G. The web ordering screen will only accept orders for VINs that are in an "Open" status.

Important Safety Notice:

The National Traffic and Motor Vehicle Safety Act prohibits the delivery of any subject vehicle without performing the necessary repair for defects or failures. Failure to perform applicable recalls before delivery can result in extensive dealer fines and penalties from the Federal Government. Therefore, you must complete this recall for all affected vehicles in your inventory prior to delivery.
