Issue What We're Doing	Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vans, has determined that certain Mercedes-Benz Metris vehicles (platform 447 (VS20)) with an integrated backup battery located beneath the front passenger's seat box were produced without a seat base cover. Without a seat base cover, the opening in which the integrated backup battery is located can become exposed when moving the seat forward. An object containing conductive material, such as metal, could be unintentionally dropped into the opening and make contact with the poles on the battery. Were this to occur, it could result in a short circuit, increasing the risk of a fire. An authorized Mercedes-Benz dealer will retrofit and install the seat base cover in the

Without a seat base cover, the opening in which the integrated backup battery is located can be exposed when the seat is moved forward. An object containing conductive material, such as metal, could be unintentionally dropped into the opening and make contact with the poles on the battery. Were such contact to occur, a short circuit could result, increasing the risk of a fire. An authorized Mercedes-Benz dealer will retrofit and install the seat base cover in the potentially affected vehicles.
