Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that certain Model Year ("MY")19 GLC-Class (253 platform) vehicles could be equipped with incorrect country variants of the airbag warning labels on the outside of the passenger side sun visor. In such case, the airbag warning labels in affected vehicles may not meet local requirements. All the labels installed include pictograms indicating the proper use of a child seat but the accompanying explanations might not be in the local language. If a sun visor label is in a foreign language, an occupant may not be aware of the risks a deploying airbag may pose to children sitting in the front seat, potentially increasing the risk of injury in the event of a crash. An authorized Mercedes-Benz dealer will check the airbag warning labels on the passenger side sun visor of the affected vehicles and replace the sun visor incl. warning label, as necessary.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired. Always Check VMI for any open campaigns, and perform accordingly.
- VMI must always be checked before performing campaigns to verify that the campaign is required on a specific vehicle. Always check for any other open campaigns, and perform accordingly.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.

Please note that Recall Campaigns **do not expire** and may also be performed on a vehicle with a vehicle status indicator.

i Incorrect versions may have been applied.

i The information labels are applied on the outer side of the front passenger sun visor.(Figure1)

- A. Incorrect version of airbag information label applied: Carry out work procedure.
- **B.** Correct US/English version of airbag information label applied: End measure.

Work procedure

1. Replace sun visor (AR68.60-P-5480NKB) and airbag information label.

i It is not possible to remove just the airbag information label from the sun visor, as the information label is part of the sun visor. The sun visor must be replaced along with the new label.
