### **RE: SECOND NOTICE - COMPLIANCE RECALL – BENTLEY MULSANNE REAR SEAT BELT ANCHORAGE PLATE**

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Bentley Motors has decided that 2012 to 2018 model year Bentley Mulsanne vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) number 210, "Seat Belt Anchorages." Our records show that you are the owner of a vehicle affected by this action.

- What is the issue?** Bentley has identified that the seat belt anchorages may not fulfil the regulatory load requirements if the rear center seat is occupied at the same time as a rear outboard seat. In a crash, the rear seat belt buckle may become detached from the vehicle body structure, increasing the risk of injury.
- What will we do?** To correct this noncompliance, your authorized Bentley Retailer will install an additional reinforcement plate to the vehicle body structure to improve the strength of the rear seat belt mounting in the vehicle. This work will take about 3 hours to complete and will be performed for you free of charge.
- What should you do?** Please telephone your authorized Bentley Retailer without delay to schedule this recall repair. Your Retailer has all the necessary instructions to perform this important safety repair to your satisfaction.
- Lease vehicles** If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten (10) days of receipt.
