**Subject: Porsche Safety Recall AKA4 - Side airbag sensors in your vehicle**

Dear Mr. f

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect which relates to motor vehicle safety exists in certain 2018 Model Year Porsche 718 Boxster, 718 Cayman, and 911 vehicles. Our records show that you are the owner of a vehicle affected by this action.

**What is the issue?**

On the affected vehicles, the side airbag sensors may not have been tightened to specification and could become loose over time. This could impair the effectiveness of the restraint system. In the event of a crash, the air bags may not deploy, increasing the risk of injury.

**What will we do?**

Your authorized Porsche dealer will inspect the side airbag sensors and tighten them to specification, if necessary.

**What should you do?**

Please contact your authorized Porsche dealer as soon as possible to schedule a remedy appointment and to arrange for a Porsche loaner vehicle if you need it. The remedy is expected to take approximately one hour to complete.

**Lease vehicles and address changes**

If you are the lessor and registered owner of the vehicle identified in this action, Federal law requires you to immediately forward this letter to the lessee. If you have changed your address or sold the vehicle, please fill out the enclosed prepaid Owner Reply Card and mail it to us so we can update our records.

**Reimbursement**

This recall will be carried out at no expense to the customer for parts and labor. If you previously paid to have this repair performed, you may be eligible for reimbursement. For more information, please contact the Porsche Customer Commitment Department as instructed below.
