Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2016-2017 AMG GT-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

DAG has determined that on certain MY 2016-2017 AMB GT-Class vehicles, the bonding between the carbon-fiber driveshaft and the engine-/transmission flange might not meet current production specification. If the bonding between the carbon-fiber driveshaft and the flange does not meet specification and is insufficient, the driveshaft might detach during vehicle operation. This could affect the performance of the transmission and in some cases, lead to a loss of traction between engine and transmission. If this were to occur, there could be a loss of the vehicle's drive power, increasing the risk of a crash.

What will your DEALER DO?

An authorized Mercedes-Benz dealer will replace the carbon-fiber driveshaft, including the flange, on the affected vehicles. This service will be provided free of charge. We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be up to 10.5 hours, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.

Information for Owners

In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations. If you have already paid to have this recall condition corrected you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. Please see the following page for more information.

- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
