

## **IMPORTANT SAFETY RECALL 2019100001**

This notice applies to your vehicle, VIN: Check Driver's Airbag Module Locknut NHTSA Recall # 19V685 Christian Treiber Vice President Customer Services

Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2019-2020 CLA-Class, A-Class, and GLC-Class vehicles. Our records indicate that your vehicle is affected.

What is the CONCERN?	DAG has determined that on certain MY 2019-2020 A-Class (177 platform), CLA-Class (118 platform), and GLC-Class (253 platform) vehicles, the four locknuts securing the driver's side front airbag might not have been installed according to current production specification. In the event of a crash necessitating deployment of the driver's-side front airbag, the airbag module might separate from the base plate and enter the passenger compartment with high velocity. The restraint effect of the driver airbag might be impaired and increase the risk of injury for the occupants in the event of a crash.
<i>What will your DEALER DO?</i>	An authorized Mercedes-Benz dealer will check the driver's airbag module on the affected vehicles and replace it, if necessary. <u>This service will be provided free of charge</u> . We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the repair time can be up to <b>30 minutes</b> , your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes- Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.
What should YOU DO?	For additional information and to schedule an appointment, please contact your preferred authorized Mercedes-Benz dealer at your earliest convenience. You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope.

If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.
