This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2019 & 2020 Connect and Sportsmen models. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with flip down storage racks. The brackets used to mount the storage rack can fail and could result in the rack and any contents to become separated from the vehicle which may result in a crash.

What we will do

The remedy is to change the existing mounting brackets and inspect the storage rack. If the storage rack is damaged, a new storage rack will be provided. This repair will be completed free of charge. The repair should take approximately 1 hour to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle. If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
