#### **IMPORTANT SAFETY RECALL**

This notice applies to your vehicle with VIN:\_\_\_\_

Trail King has decided that a defect which relates to motor vehicle safety exists in the Coupler Plate on certain Trail King TKACS & TKAACS Step Deck Trailers. Only trailers with manufacture dates from July 1<sup>st</sup>, 2015 through January 31<sup>st</sup>, 2017 that have 14" King Pin settings are effected.

#### What Trailers are being recalled?

This recall affects Trail King TKACS/TKAACS 2016-2017 model years with 14" King Pin settings that have manufactured dates 7/1/2015 through 1/31/2017.

#### What is the Problem?

Trail King has decided that these specific models with 14" King Pin settings can develop cracks in the rear of the coupler plate. If the condition is not addressed and the Coupler Plate cracks entirely, the trailer may become disengaged from the tractor, increasing the risk of a crash.

#### What should you do?

Obtain and confirm your trailer's serial number from the VIN plate located on the driver's side beam of the upper deck area. You are receiving this letter because our records show you are the current owner of this vehicle.

You should inspect the Coupler Plate for the presence of any cracks near the outer edges. Please contact your nearest Trail King Industries dealer to have your trailer inspected and repaired. We will send the parts needed to the dealer to repair your trailer.
