

# RENOTIFICATION IMPORTANT SAFETY RECALL

THIS IS A RENOTIFICATION TO AN EARLIER COMMUNICATION ISSUED ON JULY 3, 2019 WHICH NOTIFIED ALL OWNERS OF THE AFFECTED 2011-2012 MODEL YEAR SPORTAGE VEHICLES OF A SAFETY RECALL. OUR RECORDS INDICATE THAT YOU ARE THE CURRENT REGISTERED OWNER OF THIS VEHICLE AND THAT IT HAS NOT YET BEEN REPAIRED.

KIA IS REQUESTING THAT YOU CONTACT AN AUTHORIZED KIA DEALERSHIP IMMEDIATELY TO SCHEDULE AN APPOINTMENT TO REPLACE THE OIL PRESSURE SWITCH (OPS) WITH AN IMPROVED ONE THAT WILL DETECT THE EARLY ONSET OF OIL LEAKING. IN ADDITION, DEALERS WILL INSPECT THE OIL PAN FOR ANY OILS LEAKS. IF AN OIL LEAK IS FOUND, THE OIL PAN WILL BE REPLACED AT NO COST FOR PARTS OR LABOR TO YOU.

IF YOU HAVE ALREADY TAKEN YOUR VEHICLE TO A KIA DEALER AND HAD THIS SAFETY RECALL PERFORMED, PLEASE DISREGARD THIS NOTICE.

Dear Kia Sportage Owner:

#### Kia has identified a defect in your vehicle which relates to motor vehicle safety.


This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Kia Motors has decided that a defect which relates to motor vehicle safety exists in certain 2011-2012 MY Kia Sportage vehicles. The defect may cause oil to leak from the oil pan. If a vehicle is continued to be driven with an unrepaired oil leak, damage to the engine can occur and the vehicle could stall while in motion. An engine stall can increase the risk of a crash. There is also a possibility that a fire could occur, increasing the risk of injury. You were previously advised that Kia was working on a repair remedy for this defect. **The remedy to repair your vehicle is now available.** 

#### What Is The Problem?

The oil pan may have been improperly sealed during engine production. As a result, if the vehicle is continued to be driven with an oil leak, damage to the engine can occur and the vehicle could stall while in motion, increasing the risk of a crash. There is also the possibility that a fire can occur, increasing the risk of injury.

Please note that the following warnings may identify that the above condition is present. These include 1) oil on the ground after the vehicle is parked, 2) oil on underbody surfaces of the vehicle, 3) smell and/or smoke associated with oil on hot

surfaces, 4) the illumination of the Check Engine (Malfunction Indicator) Light and/or Engine Oil Pressure Warning Light in the Instrument Panel; and 5) reduced power/hesitation.



<u>Kia Will Replace the Oil Pressure Switch, and, if an Oil Leak is Detected, Will Replace the Oil Pan at No Cost</u> for Parts and Labor to You.

Kia has advised its authorized dealers to replace the Oil Pressure Switch (OPS) with an improved one that will detect the early onset of oil leaking. In addition, dealers will inspect the oil pan for any oil leaks. If an oil leak is found, the oil pan will be replaced at no cost for parts or labor to you.

#### What Should You Do?

- In the interest of the safety of your passengers, as well as your own safety, please immediately contact your Kia dealer to arrange for the recall repair to be conducted. The estimated time required to inspect and perform necessary repairs will be approximately two (2) to three (3) hours. However, the vehicle may be needed longer; therefore, we recommend scheduling a service appointment to minimize any inconvenience.

#### What If You Have Already Paid To Have This Situation Corrected?

Pursuant to the General Reimbursement Plan issued by Kia pursuant to Federal Regulation 49 CFR 573.13, Kia will use its best efforts to respond to your claim within sixty (60) days of receipt and at that time Kia may either accept or reject that claim or it may request more information to evaluate the claim.

#### Have You Changed Your Address Or Sold Your Kia?

If you have changed your home address, sold your Kia vehicle, or no longer own your vehicle, please complete the attached prepaid "Change of Address/Ownership" card and mail it to us. You can also contact the Consumer Assistance Center phone number listed above.

### What If You Are A Vehicle Lessor?

Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

#### OR Code Use:

- A QR Code is a square, 2-dimensional barcode that can be read by mobile devices loaded with an appropriate barcode or **QR Code Reader App**. The app reads the barcode image and then launches/uploads the specific information the code contains, such as URLs, text, photos, videos.
- With a mobile device, download a QR Code Reader App. With many devices, you can do this through an app store or marketplace.
- Open the QR Code Reader App on your mobile device. The app will utilize your device's camera. Center the code in the camera viewing area.
