## <u>RENOTIFICATION</u>

Dear «Owner\_name»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2019 Escape, Sonic Lite and Sportsmen Classic models. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with Capital cooktops in the inside kitchen. In certain conditions, the burners fail to operate correctly and could result in the surface becoming extremely hot resulting in personal injury and/or property damage.

What we will do

The remedy is to replace the existing Capital cooktop with a comparable Suburban cooktop. The repair should take approximately 30 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
