Dear Mazda Owner:

What is the problem?

In June 2019 Mazda announced a recall affecting certain Mazda3 vehicles, in which the front windshield wipers may become inoperative due to a defective relay that disrupts electrical power to the wiper motor. Drivers may experience reduced or poor visibility while driving due to inoperative front windshield wipers, increasing a risk of crash. As of June 22, 2020, our records indicate your vehicle is still unrepaired.

What should you do?

Mazda is concerned about your safety, and we encourage you to contact any authorized Mazda dealer to schedule an appointment to have your Mazda vehicle repaired as soon as possible. You do not need to bring this notice to the dealer, but it may assist in the check-in process.

Where is the closest Mazda dealer?

What if you already paid for repair related to this concern?

If you have already paid for repairs due to conditions similar to this recall campaign prior to June 2019 you may be eligible for reimbursement of reasonable repair expenses based on Mazda's repair standards. Please visit www.mazdareimbursement.com and enter your Vehicle Identification Number (VIN). Follow the online screen prompts to enter the relevant information to submit your claim. For further questions, or, for vehicle owners that prefer submitting claims by mail, contact the Mazda Customer Experience Center at 1-800-222-5500, Option #4. Note for online claims, allow 3-4 weeks for processing and for claims sent by mail, allow 6-8 weeks for processing.


