

IMPORTANT SAFETY RECALL

This INTERIM notice applies to your vehicle, VIN: Carbon-Fiber Driveshaft Bonding NHTSA Recall #19V457 Christian Treiber Vice President Customer Services

Dear Mercedes-Benz Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler AG ('DAG'), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year ("MY") 2016-2017 AMG GT vehicles (C190 platform), the bonding between the carbon-fiber driveshaft and the engine/transmission flange might not meet current production specification.

What is the Concern?

DAG has determined that on certain MY 2016-2017 AMG GT-Class vehicles, the bonding between the carbon-fiber driveshaft and the engine-/transmission flange might not meet current production specification. If the bonding between the carbon-fiber driveshaft and the flange does not meet specification and is insufficient, the driveshaft might detach during vehicle operation. This could affect the performance of the transmission and in some cases, lead to a loss of traction between engine and transmission. If this were to occur, there could be a loss of the vehicle's drive power, increasing the risk of a crash.

To remedy this recall issue, an authorized Mercedes-Benz dealer will replace the carbon-fiber driveshaft, including the flange, on the affected vehicles. Unfortunately, the parts to remedy this are not yet available.

We are working to obtain the necessary parts to correct this condition as quickly as possible. As parts become available, we will send you another letter asking you to take your vehicle to an authorized Mercedes-Benz dealer to have the recall completed free of charge.

Should you have any concerns or questions regarding your vehicle before you receive the next recall letter, please contact an authorized Mercedes-Benz dealer. If for any reason a dealer is unable to remedy your situation once parts are available, we are always happy to hear from you. Please contact us at 1-(800) FOR-MERCEDES (1-800-367-6372). A new vehicle identification number (VIN)-based recall lookup tool, on our MBUSA.com website, now offers a search function that will indicate whether a vehicle has been subject to a safety recall, and whether that vehicle has had the free remedy performed. If you are no longer the vehicle owner, or have a change of address, please complete the reverse side of this letter and return the complete letter in the enclosed envelope. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 days to comply with federal regulations.

If a Mercedes-Benz dealer for any reason is unable to remedy the situation without charge, or within a reasonable amount of time, pursuant to law 49 U.S.C.
