



IMPORTANT SAFETY RECALL INTERIM NOTICE

A safety defect exists in your vehicle.

- Remedy parts are not yet available for your vehicle.
- We will contact you again once parts are available.

Dear Valued Mercedes-Benz Metris Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2016 - 2020 Mercedes-Benz Metris vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

MBAG determined that certain Mercedes-Benz Metris vehicles (platform 447 (VS20)) with an integrated backup battery located beneath the front passenger's seat box were produced without a seat base cover. Without a seat base cover, the opening in which the integrated backup battery is located can become exposed when moving the seat forward. An object containing conductive material, such as metal, could be unintentionally dropped into the opening and make contact with the poles on the battery. Were this to occur, it could result in a short circuit, increasing the risk of a fire.

We want to assure you that Mercedes-Benz USA is taking all necessary measures to remedy this situation for you. We are also working closely with the National Highway Traffic Safety Administration ("NHTSA") and airbag suppliers to provide a remedy as soon as possible, and to prioritize repairs according to risk factors identified through testing. **Unfortunately, replacement parts are not yet available for your vehicle, and we will contact you again once parts become available.**

As soon as a suitable replacement part is available for your vehicle, we will send another letter notifying you to bring your vehicle to your local Authorized Mercedes-Benz Sprinter dealer to repair your vehicle free of charge.

In the meantime, please visit www.mbvans.com/sprinter/owners-resources/recall and enter your 17 digit VIN in the VIN Look-up tool, then enter your most recent contact information.

We also encourage you to sign up for recall alerts at www.nhtsa.gov/alerts.

In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.

We apologize for any inconvenience this situation may cause you.
