Description of Defect :

Description of the Defect : The back cushion may not fully engage when rotated from stowed to upright, design use position.

FMVSS 1 : 207 - Seating systems

FMVSS 2 : 210 - Seat belt assembly anchorages

Description of the Safety Risk : In the event of a crash, the back cushion may not support the appropriate loading increasing the risk for injury.

Description of the Cause : If the back frame weldment is too narrow and it is assembled to the seat base weldment this may result in deforming the dump mechanism causing it to malfunction.

Identification of Any Warning that can Occur : There needs to be an audible click of the mechanism locking into position and the mechanism handle will rotate downwards when the back cushion is rotated from the stowed to the upright, design use position.

Chronology :

During May 2018 two separate, isolated field issues were communicated to Freedman by the same customer involving a deformed seat back index pin and a back cushion mechanism not locking allowing the back cushion to over rotate beyond the design use position. During June and July 2018 there were several visits to one customer where Freedman inspected several seats, discussed the issue with the customer and Freedman reviewed its seat design and manufacturing processes. After customer visit on July 25, 2018 and despite the fact there has been seat issues at only one customer Freedman concluded there is a probability the defect could occur at other customers.

Description of Remedy :

Description of Remedy Program : Freedman will notify those vehicle builders who purchased the seat and Freedman will provide a Seat Inspection & Repair Procedure. Freedman will reimburse the cost of repairs relating to this recall, including both parts and labor, at no cost to the vehicle manufacturer or vehicle owner. Parts for this recall are anticipated to be available for shipment on or before September 15, 2018. The recall will begin September 30, 2018. Vehicle owners may contact Freedman Customer Service at 800-443-4540

How Remedy Component Differs from Recalled Component : There is no visual indication that would differentiate the recalled GO-ES Foldaway Seat (p/n 43705, 45467, 48923, 75719) from a remedy seat.

Identify How/When Recall Condition was Corrected in Production : There was a design change by Freedman to add a gusset to seat back index pin on May 31, 2018. Welding fixture for the back frame weldment was modified the week of June 18, 2018 and returned to production.
