Problem Description:

Navistar, Inc. (Navistar) is recalling certain 2019-2020 International LT and 2018-2021 International HX vehicles. The brake light switch may have a weak solder joint, possibly resulting in a poor electrical contact and inoperative brake lights or brake lights that stay on.

Consequence:

Inoperative brake lights or brake lights that stay on can cause confusion to other drivers on the road and increase the risk of a crash.

Remedy:

Navistar will notify owners, and dealers will replace the brake light switch, free of charge. The recall is expected to begin May 18, 2020. Owners may contact Navistar customer service at 1-800-448-7825. Navistar's number for this recall is 20501.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
