EQUIPMENT:RECREATIONAL VEHICLE/TRAILER PARKING BRAKE WHEELS

**Potential Number of Units Affected:** 499

## **Problem Description:**

Transcraft Corporation (Transcraft) is recalling certain 2016-2021 Platform trailers equipped with certain fork lift kits and adjustable wheel stops. The adjustable wheel stops may detach.

### **Consequence:**

If the wheel stop detaches while the trailer is parked and in use, there is an increased risk of crash or injury.

#### Remedy

Transcraft notified owners and provided repair instructions to inspect and repair the wheel stop assemblies, free of charge. The recall began November 13, 2020. Owners may contact Transcraft customer service at 1-877-489-9020. Transcraft's number for this recall is B20016.

Please be reminded of the following requirements:



Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
