Descriptive Information: Jaguar Land Rover is conducting a voluntary equipment recall campaign

involving three headliners supplied for use on United State specification 2020 Model Year Land Rover Range Rover Evoque vehicles where the headliners supplied have been incorrectly manufactured. The affected parts were built by

the supplier January 09, 2019 to March 17, 2020.

Three parts which could have been installed into vehicles in the following VIN

range: SALZM2GX4LH000866 to SALZJ2FX6LH099068.

The basis of the recall population was derived from Jaguar Land Rover data where the vehicles affected was determined by delivery records of which retailers have received the affected service replacement headliners.

# **Description of Noncompliance:**

Noncompliance: 2020 Model Year Land Rover Range Rover Evoque headliners. The replacement

service headliners supplied were manufactured without a required metal plate,

a condition that does not meet the original design intent.

Parts in this condition will not meet the upper interior head impact protection requirements of Federal Motor Vehicle Safety Standards FMVSS 201U Occupant

Protection in Interior Impact Upper Interior Head Impact Protection.

#### **Chronology:**

A Product Safety and Compliance Committee (PSCC) investigation was opened on March 4, 2020 where the committee were informed by an internal alert, certain service part headliners for US market L551 Range Rover Evoque vehicles may have been manufactured away from design intent, which requires metal plates to be

installed for US specification parts. The PSCC requested Supplier Technical Assistance (STA) to investigate the issue. STA informed the PSCC the service headliner parts were manufactured following a different process to those manufactured for original equipment supply. The different process failed to request the installation the required metal plates onto service headliner assemblies.

The PSCC requested the Jaguar Land Rover aftermarket parts function service headliner supply records to identify any headliners supplied to the US market. On March 10, 2020, the aftermarket team advised there were 3 parts supplied to the US market for aftermarket use.

Discussion with Jaguar Land Rover North America aftermarket team indicated these parts were sold to US retailers. On March 17, 2020 the PSCC progressed the issue to Recall Determination Committee (RDC).

The RDC reviewed all information available on March 19, 2020 and determined that parts made without the metal plate do not meet the requirements of FMVSS 201U and concluded a non-compliance defect exists and an equipment recall be conducted.

There have been no reported accidents, injuries or fires as a result of this concern.

## **Description of Remedy:**

Description of Remedy Program: Where an affected VIN is determined the owner will be notified and

instructed to take their vehicle to a Land Rover authorized repairer to have the headliner replaced. Otherwise a notification to retailers to identify the customer of the defective headliners will be issued and these

customer will be requested to return the headliner for exchange.

The affected vehicles will be covered under Land Rover's new vehicle warranty program. There will be no charge to owners for this repair.
