was not compliant to FMVSS NO. 304. The report showed that the font size was too small and that it was missing the Type 3 identification for 327L cylinders tested. Four cylinders were tested and had the same non-compliance. WFT started shipping CNG cylinders in 2018. From 2018 until the date of this report, WFT shipped five 327L cylinders with this label problem not including the 4

tested at SRI.

## **Chronology:**

On February 13th 2020, WFT received the final draft report (dated May 3rd 2019) outlining the noncompliance. The cylinders met the requirements for pressure cycling test, hydrostatic burst test and bonfire tests, but the cylinder labels were not compliant with FMVSS No. 304 (section 12.4) labeling. WFT's corrective action was due and provided to Leroy Angeles (Safety Compliance Engineer with NHTSA) on March 12th 2020. An online recall account to safercar.gov was set up on 3/27/20.

#### **Description of Remedy:**

Description of Remedy Program: New FMVSS No. 304 cylinder labels have been made and will be used on all

future cylinder shipments. Five replacement labels have been made for the 327L cylinders that were shipped from WFT. The replacement labels will be shipped to the three customers to install on the 5 shipped cylinders.
