Description of Defect:

Description of the Defect: The product and its accompanying materials do not adequately instruct the

operator that trailer brake functionality via foot pedal is unavailable when used in conjunction with certain 7-Way Trailer Connectors, while the tow vehicle's 4-Way Hazard Warning Signals are activated. The manual hand-held "override"

trailer braking will continue to function as intended.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: If a driver of a vehicle equipped with certain 7-way trailer connectors is not

aware that trailer braking via foot pedal is unavailable while the 4-Way Hazard Warning Signals are in use, a delay in applying the manual hand-held brake may reduce the driver's ability to safely operate and maintain control

of the tow vehicle, increasing the risk of a vehicle crash.

Description of the Cause: Updated error messaging and product instructions introduced for the

upgraded Prodigy® RF Electronic Brake Control with Bluetooth did not

sufficiently describe functionality.

Chronology:

April 30, 2020 – Horizon initiated an investigation into a customer satisfaction issue of "no or intermittent connectivity" (n.c. error code) of Horizon's newly offered Prodigy® RF Electronic Brake Control with

Bluetooth, 902501.

April 30 - May 13, 2020 - Horizon conducted recurring meetings among key teams (technical, product management, quality) to investigate the connectivity issue.

May 13, 2020 - During the course of investigating the connectivity issue (which does not affect trailer brake functionality or other product performance), a separate and unrelated issue was identified, i.e. the planned interaction of simultaneous trailering brakes + 4 Way Hazard resulting in disabling foot pedal activation of the trailer brakes under certain circumstances. Horizon Global leadership sought clarification from the technical teams regarding this functionality.

May 18, 2020 - After analysis and evaluation, the technical teams confirmed that this functionality was introduced into the product during an upgrade from the previous version of the trailer brake control, but that the product and its accompanying instructions do not instruct or warn operators when the foot pedal functionality is deactivated, which can occur while the 4-Way Hazard Warning Lights are activated, in conjunction with certain installed 7-Way Trailer Connectors.

May 22, 2020 – Based upon the findings of the investigation team, Horizon Global leadership decided to conduct this safety recall to address this issue.

There have been no reports of accidents, injuries, or customer complaints regarding this issue.

Description of Remedy:

Description of Remedy Program: Horizon will coordinate with dealers and distributors to identify and notify

all purchasers of the subject products. Horizon will provide, free of charge, a replacement product that provides notice/indicators to the driver when

foot pedal braking is unavailable, along with updated instructions.

All of the subject products remain under the manufacturer's warranty. Therefore, pursuant to 49 CFR 577.11(e), Horizon Global requests an

exemption from the reimbursement plan requirements.

How Remedy Component Differs The replacement product will provide notice/indicators to the driver from Recalled Component: when foot pedal braking is unavailable, along with updated instructions. The replacement Kit will be Part No. 902502 and the replacement Hand

Held will be Part No. 90255.

Identify How/When Recall Condition This product was last produced on May 6, 2020 and shipments were was Corrected in Production: suspended as of May 15, 2020. Updated products are expected to be

available for shipment in mid-June, 2020.
