Description of Defect :

Description of the Defect : The Rubicon Express 4.5/5.5" suspension lift kit fitment guide is not accurate in connection with stating that 40 inch tires are compatible with the kit.

FMVSS 1 : NR

Description of the Safety Risk : Due to an inaccurate fitment guide, Rubicon Express 4.5/5.5" suspension lift kits used in combination with 40 inch tires may reduce vehicle stability in certain emergency maneuvering situations, thereby increasing the risk of a crash.

Description of the Cause : An inaccurate fitment guide resulted in some Rubicon Express 4.5/5.5" suspension lift kits being sold with 40 inch tires.

Identification of Any Warning that can Occur : Customers may notice reduced vehicle stability in certain emergency maneuver situations.

Chronology :

Consistent with TAP's regular safety compliance and testing program, in or about early June 2020, TAP tested model year 2020 Jeep Gladiator Rubicon Edition vehicles equipped with Rubicon Express 4.5/5.5" suspension lift kits. Following this testing, it was identified that Rubicon Express 4.5/5.5" suspension lift kits used in combination with 40 inch tires may reduce vehicle stability in certain emergency maneuvering situations. As a result, TAP actively investigated the matter. In or about late June 2020, TAP's investigation identified that the Rubicon Express 4.5/5.5" suspension lift kit fitment guide is not accurate in connection with stating that 40 inch tires are compatible with the kit, which resulted in a limited number of kits being sold with 40 inch tires. Subsequently, TAP brought this matter to the Polaris Inc. Executive Review Committee, in accordance with the company's established product safety procedures. Upon review, on June 30, 2020, the Executive Review Committee decided to conduct a voluntary recall for a safety-related defect.

Description of Remedy :

Description of Remedy Program : TAP will notify consumers who purchased Rubicon Express 4.5/5.5" suspension lift kits. For the limited number of consumers who purchased Rubicon Express 4.5/5.5" suspension lift kits with 40 inch tires, TAP will replace the fitment guide and replace the 40 inch tires with tires of an appropriate size. For all other customers, TAP will replace the fitment guide only. All costs will be covered and consumers will not be charged.

How Remedy Component Differs from Recalled Component : The replacement fitment guide will be accurate as to all applicable tire sizes. Tire sizes will be compatible with the suspension kit.

Identify How/When Recall Condition was Corrected in Production : The inaccurate fitment guide was identified in or about June 2020 during TAP safety and compliance testing, as set forth above. All fitment guides will be correct going forward, and no 40 inch tires will be provided in combination with the suspension kit.

Description of Recall Schedule : Owners and retailers will be notified on or before September 8th, 2020. To supplement and provide additional awareness of the subject recall TAP will perform enhanced outreach to affected customers and retailers by direct phone and email.
