Walmart Compliance was notified by an independent third party testing laboratory of a test failure due to a failure with the ratcheting bar on July 13, 2020 and pulled the item from shelves on the same day. Walmart conducted an investigation into the item's safety and engaged with NHTSA on July 15, 2020 regarding the possible issue. Walmart tried to report to NHTSA on July 28, 2020, but was accepted into NHTSA's system to file a report on July 31, 2020.
