Ridgeline is a tri-fold design that can be positioned to either partially cover (open) or completely cover (closed) the truck bed. If the tonneau cover is not properly secured in the open or closed position, and the vehicle is operated at highway speeds, the wind resistance may cause the tonneau cover to flip and

buckle, deforming the hinges between the center and rear panel.
