Chronology:

In or about January 2020, LLIT was contacted by the NHTSA Office of Vehicle Safety Compliance (OVSC) regarding potential noncompliance of the subject tires. This potential noncompliance was identified by a third-party test on test tire 1907753, LT265/75R16 LRE Venezia Crusade HT, DOT YCLF LLTR 4115. Because the subject tire had not been manufactured since December 2015, in or about late January 2020, LLIT reproduced several exemplar subject tires for FMVSS No. 139 additional testing. In or about early February 2020, LLIT complete its testing. Just as the tires originally produced in June 2015 passed both endurance and high speed testing all exemplar subject tires passed 139 testing as well. On or about February 6, 2020, LLIT responded to OSVC's written information request. Between January 2020 and June 2020, LLIT promptly investigated the matter, conducted the aforementioned confirmatory testing, and cooperated with OVSC. On June 17, 2020, LLIT met with OVSC to further discuss the testing and field experience including the abence of any claims of lower sidewall seperations. On or about July 24, 2020, with NHTSA's permission, LLIT conducted a further visual inspection of test tire 1907753, LT265/75R16 LRE Venezia Crusade HT, DOT YCLF LLTR 4115. The test tire exhibited lower sidewall deflection. On August 5, 2020, with great respect for NHTSA, and out of an abundance of caution, LLIT decided to conduct a voluntary recall of the subject tires.

Description of Remedy:

Description of Remedy Program: Because the subject tire has not been manufactured since December 2015, LLIT will recall all tires in the subject population and replace them with comparable tires that comply with FMVSS No.139. LLIT will contact registered customers that purchased tires of the specified date range by first class mail. For those customers who did not register their tires, LLIT will work with independent dealers or distributors to obtain owner information, where available. In accordance with Part 577, customer correspondence will explain the issue, and include instructions on how to obtain replacement tires, as well as instructions for collecting reimbursement for remedies made prior to the recall, if any.

> Customers who have had their tires replaced before this recall may be eligible to receive reimbursement for the cost of obtaining a prenotification remedy of the problem associated with this recall. The reimbursement period began on October 15,2019 and will end 10 calendar days after the date on which LLIT mails the last of its non-compliance notifications to owners. Dealers performing the replacement of recalled tires will be notified of their responsibilities in accordance with 49 C.F.R. Part 573.6(c)(9). Tires to be disposed of after removal of DOT serial number.

How Remedy Component Differs Due to the subject tires being out of production since December 2015 for from Recalled Component: those customers who choose to receive a replacement tire(s), the replacement tires will comply with all applicable requirements of FMVSS No. 139.
