## **Chronology:**

On December 26, 2019, certification labels containing incorrect GAWR information were detected during a routine quality control inspection at the vehicle assembly plant. HMC surveyed potentially affected vehicles from December 27, 2019 through January 7, 2020 using recent production records to identify a suspect vehicle population. HMC confirmed certain vehicles had been shipped to dealers with noncompliant certification labels and communicated their findings to HMA on January 7, 2020. Based on the information received, on January 10, 2020, HMA convened its Technical Committee and decided to conduct a noncompliance recall for those vehicles affected in the U.S. market.

To date, Hyundai is unaware of any incidents, crashes, or injuries related to this condition.

#### **Description of Remedy:**

Description of Remedy Program: Hyundai Motor America plans to notify owners of affected vehicles to

return their vehicles to their Hyundai dealers to install new label stickers over the affected areas of the certification label. This procedure will be

performed at no charge.

Hyundai will provide reimbursement to owners for repairs according to
