Description of the Defect : The Federal Placard incorrectly states the axle rating, tire/wheel size, and tire PSI.

FMVSS 1 : 120 - Wheels and rims- other than passenger cars

FMVSS 2 : 567 - Certification

Description of the Safety Risk : An operator may unknowingly overload the vehicle, increasing the risk of loss of control which may lead to a crash, property damage, death and/or injury.

Description of the Cause : Due to an error in the data system the tire and rim combination, data tables did not match and incorrect information was printed on the placards.

On 1/21/2020 it was discovered during a routine Federal Placard audit by the manufacturing plant that the axle and tire information was incorrectly stated. The Federal Placard indicates 7,000# front rear axle(s), ST235/85R16/G tires, 16X6.0J Rims, 110 PSI. The Federal Placard should indicate 6000# front/rear axle(s), ST235/80R16/E tires, 16X6.0J Rims and 80 PSI. Using production records the manufacturing plant was able to determine the affected vehicles.

On 1/24/2020 Forest River's Corporate Recall Committee voted to recall

Description of Remedy Program : Forest River will provide the correct Federal Placard at no charge to the owner.

How Remedy Component Differs from Recalled Component : The correct information on the Federal Placard for the axle rating and tire/wheel size, and PSI will be consistent with what is installed on the vehicle.
