Description of the Defect: Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has

determined that on certain MY 2018-2019 E-Class (213 platform), G-Class (463

platform), S-Class (222 platform), S-Class Coupe and Convertible(217 platform), and GT-Class 4-door Coupe (290 platform) vehicles with 4.01 8-cylinder gasoline-engines (M177), the elastomeric material of the oil feed line

to the turbochargers might not meet current production specifications.

Description of the Safety Risk: Due to thermal loading while driving, the oil feed line might exhibit selective

leakage. If leaked oil contacts hot components in the engine compartment the

have been produced with an elastomeric material composition that does not

## **Chronology:**

In September 2019, MBAG launched initial investigations based on three individual field reports from outside the US describing instances in which customers claimed to have experienced the subject condition. No third party damage or personal injuries were reported. MBAG requested the parts of the affected vehicles be returned from those markets for further analysis. The technical analysis continued into Fall 2019 and the initial results indicated a potential influence of the elastomeric material of the oil feed line as a factor. As the investigation was ongoing, MBAG received further field reports that appeared to be related to the same issue. The affected oil feed lines from these other vehicles were also requested to be returned to MBAG for analysis. The analysis on these additional parts also indicated the performance was influenced by the behavior of the elastomeric material.

Further review with the supplier and its production records found that the elastomeric material composition did not meet specifications for a specific production period. The supplier's records indicated that those deviations had occurred for a certain period of time in the production process without being noticed. In the investigation with MBAG, the supplier was able to identify the range of potentially affected parts. In parallel MBAG identified potentially affected vehicles based on production/logistic records. On January 17, 2020, MBAG decided to conduct a safety recall.

## **Description of Remedy:**

Description of Remedy Program : An authorized Mercedes-Benz dealer will replace the oil feed line to the

turbocharger on the affected vehicles.

Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described

and all remain covered under the new vehicle warranty.
