Description of Remedy Program: Registered owners of all affected vehicles will be contacted by mail and

asked to take their vehicle to a Honda automobile dealer. The dealer will inspect the third row seat accessory power outlet wire harness for damage and, if any copper wiring is exposed, replace the floor wire harness for free. If no copper wiring is exposed, the dealer will apply protective tape and re-route the wire harness for free. Because the new vehicle limited warranty on all affected vehicles would have provided a free repair for the problem addressed by this recall, without any payment by the owner,

reimbursement for pre-notification repairs will not be offered.
